Any loan options that no longer adhere to our criteria are removed, and new loan options are added. At least two lenders will be presented to you at all times.

You are free to choose any lender, including those not presented. If you choose a lender that is not presented, please contact OCOM’s Office of Financial Aid. Application processing will not be delayed unnecessarily if you choose a lender not presented, however we will need to confirm with your chosen lender that they will lend for the DACM degree completion program.

OCOM officials are prohibited from accepting any financial or other benefits in exchange for displaying lenders and loan options in FASTChoice. Prohibited activities include: receiving compensation to serve on any lender board of directors or advisory boards; accepting gifts including trips, meals, and entertainment; allowing lenders to staff our institution’s financial aid office; allowing lenders to place our institution’s name or logo on any of their products; and owning of lenders’ stock (for college officials who make financial decisions for our institution).
